



DIMENSIONS™ COUNTERTOPS

One-Year Limited Warranty

Belanger Laminates ("BL") warrants to the original purchasing consumer ("Purchaser") of Dimensions countertops ("Product") that the Product shall be free from defects in materials and workmanship for a period of one (1) year from the date of purchase subject to the following terms, conditions and exclusions.

This limited warranty applies only to Product in its original installation in Canada, is not transferable and expires upon resale or transfer by the Purchaser.

The Purchaser's sole and exclusive remedy against BL shall be limited to repair or replacement of Product only determined to be defective or refund of the purchase price of the defective Product only, as determined by BL in its sole discretion. In no event will BL's maximum liability exceed the amount paid by the Purchaser for Product only determined to be defective.

The following costs and expenses are not covered by the provisions of this limited warranty: (1) costs for the removal, fabrication and/or reinstallation of the Product; (2) shipping and freight expenses required to return the Product to BL; (3) normal maintenance; or (4) economic losses.

This limited warranty shall not apply to defects or damages arising from any of the following: (1) accidents, abuse or misuse; (2) exposure to temperature in excess of 93°C (200°F); (3) improper customization or installation; (4) damage due to moisture; or (5) improper maintenance including damage from abrasive cleaners or harsh chemicals.

NO OTHER WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, ARE MADE, INCLUDING, BUT NOT LIMITED TO, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT. UNDER NO CIRCUMSTANCE SHALL BL BE LIABLE FOR ANY LOSS OR DAMAGE ARISING FROM THE PURCHASE, USE OR INABILITY TO USE ITS PRODUCTS OR FOR ANY SPECIAL, PUNITIVE, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES. NO DEALER, DISTRIBUTOR, FABRICATOR, INSTALLER, AGENT OR EMPLOYEE OF BL HAS THE AUTHORITY TO ADD TO OR MODIFY THE OBLIGATIONS OR LIMITATION OF THIS LIMITED WARRANTY. THIS WARRANTY SHALL BE INTERPRETED EXCLUSIVELY UNDER THE LAWS OF THE PROVINCE OF QUEBEC. BL RESERVES THE RIGHT TO REVISE OR TERMINATE THIS WARRANTY AT ANY TIME. ONLY PRODUCT PURCHASED FROM THE EFFECTIVE DATE OF THIS WARRANTY THROUGH THE DATE OF ANY REVISION OR TERMINATION OF THIS WARRANTY WILL BE COVERED BY THIS WARRANTY.

To make a claim under this limited warranty, contact your original distributor, dealer or fabricator within thirty (30) days after discovery of any defect, but in no event more than one (1) year after the date of purchase. Evidence of purchase date for coverage under this limited warranty is required.
