IMPORTANT SAFETY INSTRUCTIONS:

This product is for indoor use only. The product should not be used near water. Never immerse the lamp in water or other liquids. Never cover the lamp with any object including cloth or paper. This is not a toy.

ASSEMBLY INSTRUCTIONS:

1. Secure the tree by firmly pushing it onto the stem of the base. (See figures 1a and 1b).
2. Shape the tree by very gently pushing/pulling the branches into position.
3. Place the plastic leaves onto the ends of the tree branches. (See figure 2).
4. Attach the cord from the tree to the adapter. Plug the electrical supply adapter into the wall outlet.
5. Turn On/Off with the switch located on the cord.

****NOTE: The foil/and or black insulator that is wrapped around the tree and branches is part of the lamp do not remove!!****

CLEANING & MAINTENANCE:

1. Unplug the fixture before cleaning.
2. Use a clean, dry, lint-free cloth.
3. Do not use water or other chemical cleaning agents.

LIMITED WARRANTY

If the defects and proof of purchase are properly reported to Manufacturer within the warranty period, and the defects are of such type and nature as to be covered by this warranty, Manufacturer shall, as its own expense, furnish replacement products or, at Manufacturer's option, replacement parts for the defective products. Installation of the replacement products or replacement parts shall be at Buyer's expense.

2. Exclusive Obligation:

THIS WARRANTY IS EXCLUSIVE. The sole and exclusive obligation of Manufacturer shall be to repair or replace the defective products in the manner and for the period provided above. Manufacturer shall not have any other obligation with respect to the products or any part thereof, whether based on contract, tort, strict liability or otherwise. Under no circumstances, whether based on this Limited Warranty or otherwise, shall Manufacturer be liable for incidental, special, or consequential damages.

3. Other Statements.

Manufacturer's employees or representatives' oral or other written statements do not constitute warranties, shall not be relied upon by Buyer, and are not part of the contract for sale or this limited warranty.

4. Entire Obligation.

This Limited Warranty states the entire obligation of Manufacturer with respects to the products. If any part of this Limited Warranty is determined to be void or illegal, the remainder shall remain in full force and effect.
