IMPORTANT SAFETY INSTRUCTIONS:

This fixture must be installed by a qualified electrician!
Disconnect the power at the main electrical panel before installation.

This fixture is for indoor use only. The fixture should not be used near water. Never cover the lamp with any object, including cloth or paper as this is a fire hazard. Do not handle the bulb immediately after the light is turned off as it will be hot. This is not a toy. It is recommended that you wear gloves during assembly.

ASSEMBLY INSTRUCTIONS:

1. TURN THE MAIN POWER SUPPLY OFF
2. PLACE ALL PARTS ON A SMOOTH FLAT SURFACE
3. SLIDE SOCKET COVERS "A" ONTO THE SOCKETS ON SHADE "B"
4. SCREW SHADE "B" ONTO THE LOOP
5. ATTACH CHAIN "C" TO THE LOOP
6. PASS THE MAIN WIRE "D" THROUGH THE FIRST LINK OF THE CHAIN THEN THROUGH EVERY 3RD LINK
7. ATTACH THE MOUNTING PLATE "E" TO THE ELECTRICAL BOX "F" WITH SCREWS "G"
8. SCREW THE THREADED NIPPLE "H" INTO THE MOUNTING PLATE "E"
9. CONNECT THE SCREW COLLAR LOOP "I" TO THE THREADED NIPPLE "H"
10. PASS CANOPY "J" OVER THE SCREW COLLAR LOOP "I" UNTIL ONLY HALF OF THE SCREW COLLOR LOOP EXTERIOR THREAD IS EXPOSED.
11. REMOVE CANOPY "J" AND TIGHTEN STEEL NUT "K" TO THE MOUNTING PLATE "E"
12. SLIP THE THREADED NUT "L" AND THE CANOPY "J" OVER WIRE "D" AND CHAIN "C"
13. OPEN AND ATTACHED THE LAST LOOP OF THE CHAIN TO THE SCREW COLLAR LOOP "I"
14. PASS WIRE "D" THROUGH THE SCREW COLLAR LOOP "I", NIPPLE "H" AND MOUNTING PLATE "E"
15. MAKE THE WIRE CONNECTIONS. CONNECT BLACK TO BLACK WIRE AND WHITE TO WHITE WIRE. IF THE WIRES ARE NOT BLACK AND WHITE, CONNECT THE BLACK WIRE IN THE OUTLET BOX TO THE PLAIN OR ROUNDED SIDE OF THE FIXTURE WIRE. CONNECT THE WHITE WIRE IN OUTLET BOX TO THE RIBBED WIRE OF THE FIXTURE WIRE. ATTACH GROUNDING WIRE "M" THAT HAS THE GREEN OR YELLOW LINE TO MOUNTING PLATE GROUNDING SCREW "N".
16. INSTALL LIGHT BULBS. DO NOT INSTALL BULB THAT EXCEED THE WATTAGE FOR EACH SOCKET.

CLEANING & MAINTENANCE:

BULB REPLACEMENT

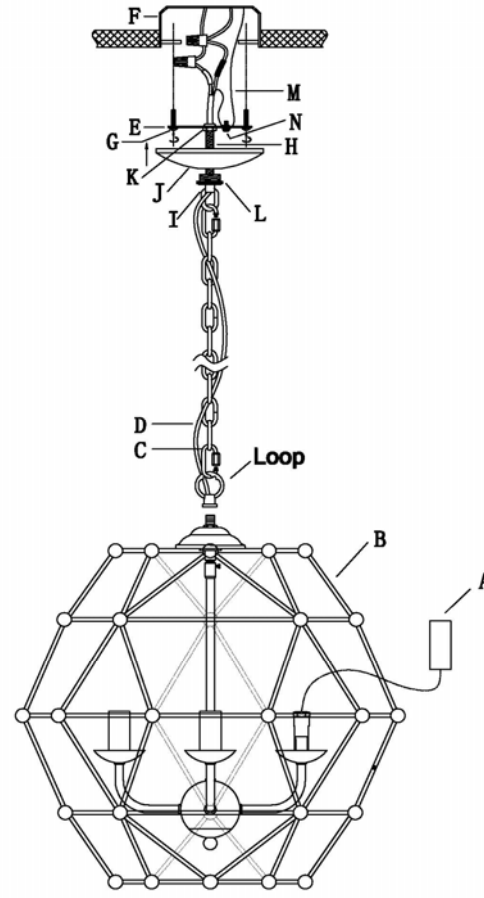
Disconnect the power before replacing bulb.

TROUBLESHOOTING

1. If lamp does not light, check the bulb for a broken filament. Replace bulb if necessary.
2. If the external flexible cable or cord of this fixture is damaged, it must be replaced by a qualified electrician in order to avoid a hazard.

MAINTENANCE

1. To clean, use a soft cloth only.
2. Do not use any chemical or abrasive cleaners.

LIMITED WARRANTY

All the Rages Inc, a New Jersey corporation, having its principal place of business at 355 Eisenhower Parkway Suite 101 Livingston, NJ 07039 (All the Rages) warrants its products (the "products") as follows:

1. Limited Warranty.

Manufacturer warrants that the products sold hereunder will be free from defects in material and workmanship for a period of one (1) year from the date of purchase. If the products do not conform to this Limited Warranty during the warranty period (as herein above specified), Buyer shall notify Manufacturer in writing of the claimed defects and demonstrate to Manufacturer's satisfaction that said defects are covered by this Limited Warranty. If the defects and proof of purchase are properly reported to Manufacturer within the warranty period, and the defects are of such type and nature as to be covered by this warranty, Manufacturer shall, as its own expense, furnish replacement products or, at Manufacturer's option, replacement parts for the defective products. Installation of the replacement products or replacement parts shall be at Buyer's expense.

2. Exclusive Obligation:

THIS WARRANTY IS EXCLUSIVE. The sole and exclusive obligation of Manufacturer shall be to repair or replace the defective products in the manner and for the period provided above. Manufacturer shall not have any other obligation with respect to the products or any part thereof, whether based on contract, tort, strict liability or otherwise. Under no circumstances, whether based on this Limited Warranty or otherwise, shall Manufacturer be liable for incidental, special, or consequential damages.

3. Other Statements.

Manufacturer's employees or representatives' oral or other written statements do not constitute warranties, shall not be relied upon by Buyer, and are not part of the contract for sale or this limited warranty.

4. Entire Obligation.

This Limited Warranty states the entire obligation of Manufacturer with respects to the products. If any part of this Limited Warranty is determined to be void or illegal, the remainder shall remain in full force and effect.
