

Vinyl Railing Stair Kit Installation Guide


READ ALL INSTRUCTIONS CAREFULLY BEFORE BEGINNING THE INSTALLATION

- 4.6cm (1/8") meta bit
- Level, Measuring
- Tape, Hacksaw
- PVC Glue or Silicone Caulk


Installation Tips:

Plan and draw your railing project to scale, using the actual measurements of your deck or balcony, including the locations where railings will be installed.

It may be necessary to cut the rails to balance the sections properly. Always cut equal lengths from each end of the rails to ensure the balusters remain centered.


If a section needs to be trimmed, make sure to remove the steel insert before cutting. **Do NOT** cut the steel insert near the PVC plastic, as steel debris can damage the plastic.

When cutting steel reinforcement inserts, apply an anti-rust primer to the cut ends to prevent corrosion.




1. Choose the location to affix the Steel Insert "N". Use a level to make sure the posts are vertical to the ground. Post distance (inside to inside) should NOT exceed 172cm/67.7". (Fig.1)


2. Use 4 screws "M"(not included; customers prepare suitable screws based on the surface where the railings will be secured) to affix "N", then sleeve vinyl post "A" to Steel Insert "N". (Fig.2)


3. Fasten the bottom rail bracket "I" onto the 2 ends of bottom rail "J" with the 4 screws provided. (Fig.3)



4. Cut the 2 ends from the ready bottom rail "J" to required length. Use the ready bottom rail "J" as the ruler to mark the 2nd post position. Do NOT fasten the 2nd post until the bottom rail is inserted into post holes. (Fig.4)


5. Use 8 screws provided "D" to fasten the ready bottom rail "J" to the posts at 2 each end. Tighten well with screw thread "A"&"N". (Fig.5)


6. Follow the same steps (3&4) for the top rail. (Fig.6 & Fig.7)

7. Assemble balusters "G" to the hole at bottom rail "J" (Fig.8)

8. Affix the top rail "E" to the posts at 2 ends by using 8 screws provided "D". Tighten well with screw thread "A" & "N". (Fig.9 & Fig.10)





9. Attach the post cap "B" onto the post with glue to finish the installation. (Fig.11)

For the purposes of this warranty, a "residential purchaser" refers to an individual residential homeowner.

If a defect occurs within the warranty period, Purchaser shall notify J. Sonic Services Inc. in writing and, upon confirmation by an authorized J. Sonic Services Inc. representative of the defect, J. Sonic Services Inc.'s sole responsibility shall be, at its option, to either replace the defective item or refund the portion of the purchase price paid by purchaser for such defective item (not including the cost of its initial installation). TO THE FULLEST EXTENT PERMITTED UNDER THE LAW, THIS WARRANTY SHALL NOT COVER AND J. SONIC SERVICES INC. SHALL NOT BE RESPONSIBLE FOR COSTS AND EXPENSES INCURRED WITH RESPECT TO THE REMOVAL OF DEFECTIVE J. SONIC SERVICES INC. PRODUCTS OR THE INSTALLATION OF REPLACEMENT MATERIALS, INCLUDING BUT NOT LIMITED TO LABOR AND FREIGHT.

ORIGINAL PROOF OF PURCHASE MUST ACCOMPANY ALL WARRANTY CLAIMS. The original residential purchaser will be notified by J. Sonic Services Inc. as to whether the warranty claim is approved or denied.

Replacement material will be provided that is as close as possible in color, design, and quality as the replaced material, but J. Sonic Services Inc. does not guarantee an exact match as colors and design may change. If a valid warranty claim hereunder is made during years eleven (11) through twenty-five (25) after the original purchaser takes possession of the product, recovery will be prorated. If J. Sonic Services Inc. is providing replacement materials, it may elect to replace the percentage listed below of rails or posts otherwise meeting the requirements for a claim, or if it is refunding the purchase price, it may elect to refund the percentage listed below of the purchase price of rails or posts otherwise meeting the requirements for a claim.
